Articles of Incorporation
of

I

The name of the corporation is Rockdale Trail Blazers Inc.

II

The corporation is organized pursuant to the provisions of the Georgia Non-Profit Corporation Code.

III

The corporation shall have perpetual duration.

IV

The corporation is a non-profit corporation, and is organized for the following purposes:

- (a) The purposes for which the corporation is organized are to promote horse shows, trail rides, and other livestock events such as cattle, sheep, hogs, and other related events for the people of Rockdale County to include 4-H Clubs and other interested people of all ages.
- (b) The corporation may own, lease, manage, and control real estate and other property for the purposes herein set out, accept gifts and contributions in any form as may be made for the purpose of promoting the objectives of the corporation, and all such gifts and contributions so made shall be devoted to and used for and in respects administered to achieve the objects of the corporation as herein set out; and may pursue any other business or businesses deemed necessary or useful to carry out the purpose and objects of the corporation.

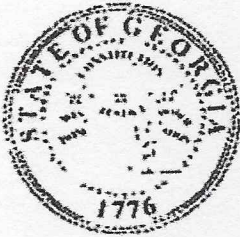
